Applicants are required to submit a personal narrative highlighting any unique background or life experiences (i.e., socioeconomic status, first-generation professional, multicultural background, geographic diversity, and any unique skills), and describing (1) the applicant's reasons for pursuing a legal career; (2) interest in private practice; and (3) any obstacles the Maynard Nexsen Scholarship will help the applicant to overcome in pursuing a legal career.
